Tlaltzin shared a <u>presentation</u> on the Survivor Coordinated Access System (S-CAS). The presentation covered the various S-CAS access points located in the community and what services they offer. Additionally, there are several local agencies that offer housing for clients eligible for S-CAS. Details were shared regarding Survivor Case Conferencing, the S-CAS referral process, and some important distinctions between Victim Service Provider CAS Assessors and the larger CAS Assessor pool. The S-CAS Team recently developed a <u>one-pager</u> that outlines the Survivor CAS pathway to services, a resource list, eligibility requirements, and contact information.
