- <u>2026 PIT Count Dates & Webpage:</u> Jesse shared that the tentative dates for the 2026 PIT Count have been selected for Monday 1/26 & Tuesday 1/27.
- <u>Methodology & PIT Consultant</u>: Nica shared details that we are not required to or plan on sending out an RFP. We are in discussion with SimTech to confirm the contract and efforts for the 2026 PIT Count. Stay tuned for specific details.
- <u>2024 Unsheltered Data Mapping:</u> Aziz shared that the SSF Data Analytics team is currently developing some street outreach mapping tools which will help inform the "known location mapping" process later in the year. This effort will assist with validating the methodology development work being completed by the consultant for this PIT.
- <u>2024 PIT Local Survey Review:</u> this will be sent out to the PITC for their feedback. At the June PITC meeting we will discuss this survey and welcome feedback.
- 2026 PIT Count Volunteer Plan: Nica shared a <u>presentation</u> about the tentative 2026 PIT Count dates, background on volunteers from previous PIT Counts, 2026 PIT Volunteer Plan, & the various volunteer opportunities/roles were shared. A new SSF staff member will be joining to lead and plan for the 2026 PIT Count.
- Specific suggestions were made for the 2026 PIT:
  - Ensure PLE members have adequate support during the actual event of the PIT.
  - Concerns were raised about enforcement activities and their impact on the PIT.
  - Increased coordination & collaboration between law enforcement & the CoC around the PIT
  - Should this PIT be a more traditional street outreach count, or should our CoC rely on more magnet events in 2026? This might encourage more community trust and collaboration with service providers (Loaves & Fishes was provided as an example.)
  - How are the concerns around data privacy at the federal level going to be addressed? (for undocumented individuals or other groups fearful of targeting)
  - Perhaps a "quiet pre-count" with collaborative partners before the actual PIT
  - Marjorie D. recommendation to focus on capturing youth who are 0-5 years, possibly a creative idea to host a "diaper drive" to capture and assist this demographic
