Jesse shared the following: <u>Scoring Tool Matrix</u>. The following metrics were reviewed & discussed by the group:

Lived Experience Involvement:

- Clark County has a higher percentage of points. Clark and ATL are narrative based. Clark is flexible and has a range for a "strong/average/weak" response which can be useful for us.
- Would a metric like this be impacted within the Federal Executive Orders around DEI?
- Could this be a good substitute for the Racial Equity work?
- We can look at this from a "trauma informed" approach
- A discussion about Youth participation

Accurate Data:

- SF scale is much larger than the other CoCs with a larger point spread. Sac definitions are preferred/straight forward. Overall, nothing specific stands out.
- Does the current 5% error rate seem appropriate from the Provider perspective? For CoC-funded programs, there is already an incentive to have excellent data, this may not be the case community-wide.

Timely Data:

- Sac has 2%. LA is unique as if they can only lose points for this metric. ATL has a higher standard, double as Sac.
- What counts as "late" for LA?
- This is not a harder metric to score. If we don't have issues/concerns, then we should leave as is. Our intention is to review the tool fully during this "off time" for the NOFO.

May PRC Meeting Discussion:

In prep for the May PRC in person meeting, what topics are preferred to discuss:

• DEI discussion, what reframing looks like, and our next steps (Meeting Focus)

- Can we invite specific consultants/others to this meeting?
- <u>Panel of CoC Providers "Listening Circle"</u> asking them what is your experience filling out your apps/looking at your data/telling their story (pros/cons). Dive into specific questions (e.g. involvement in the CoC)
- <u>Develop a "Summer Strategy"</u> for the CoC PRC & identify areas of collaboration with other departments at SSF (Finance, Grants, or HMIS) or other committees of the CoC.
- Monitor Findings How will the "Monitor Findings" factor be further fleshed out?

Action Items:

- Ask the HMIS/Data team if a 5% error rate seems aligned with their expectations.
- Look into the formula for "Timely Data" that penalizes programs that have same day data entries. The equation does not currently take those scenarios into account.
- Prepare an analysis on YHDP-specific scoring tools for a future meeting.
- SSF Staff to discuss/draft the May CoC PRC meeting agenda with the CoC PRC Chairs and share out in prep for the May CoC PRC meeting.

Sarah discussed and the PRC feedback was asked:

- Limit how many Projects one Provider can submit in the CoC Program NOFO:
 - They need to provide their track record: you cannot submit more Projects until you successfully ramp a previous CoC project.

- This is especially important for non-local agencies that submit excellent applications but have a limited local presence/understanding of the Sacramento community.
- Allow space for new projects:
 - How can smaller, more grassroots agencies fairly compete against much larger organizations?
- Require new Providers to our community to be ranked before submitting another project:
 - Should high-performing projects have an advantage when it comes to submitting additional new projects? Could high performing agencies submit more than one new project application?
 - Perhaps this advantage is reserved for projects that build-upon existing relationships with site-based developers. If CoC-funding would ensure the developer's project's success.
 - o Should there be dollar limits on new CoC applications?

Action Item:

 Develop a report that analyzes the start of a program's funding and how long that program was/is funded. This comparison may be valuable for a year-by-year comparison.
