Michele shared proposed changes to the new and renewal scoring tools for the 2024 CoC Program NOFO. Michele discussed a <u>summary document</u> outlining the key changes being considered. <u>Request to Record this Meeting:</u> Michele requested today's meeting to be recorded only for the purpose for Tom Albanese review and that the recording will not be shared publicly.  - A previous appeal happened because programs would pick their scoring factor and a change should happen.
 - striking content to be made, see page 7
 - o additional rewording is needed for this section
 - o How would shared housing impact this?
 - What about TH-RRH programs? Can we ask Kate from LSS?
 - Why not use enrollment?
 - Revisions to the Quarterly Drawdowns content, SSF role and Tom's comment/recommendation was discussed,
- 5. Severity Of Need And Service Quality:
 - Striking 5.A content and reallocating these points to somewhere else.
 - 5B. Severity of Needs & Special Considerations (would be the new 5A) revisions
 - Removed COVID-19 specific vulnerability
 - It is complicated to score this section because everyone makes a case that their population is of need.
 - 5C. Quality of Services revisions
 - Ask providers if they meet standards and if not what they will do to meet them. Michele will go back with Tom to provide some more guidance.
- 6. Compliance
 - o This section needs to be simplified and will come back for further review
