I have a few questions so I know that at least five people that have reported pipe leaks and have reported it as well front door lock issues. but a few of them had asked would it be ok to change the locks their self is that ok or no	There are some specific questions being asked about door locks. The law requires a working deadbolt on the front door, so if there is not a working deadbolt, then an advocate or tenant can write an e-mail or certified letter advising that the deadbolt is not working. You have to give the landlord a reasonable period of time (such as 30 days) to repair it, If they don't, you can help the tenant send a follow up e-mail/letter advising the landlord that the amount will be withheld from the rent in the future rent month.
What about landlords that refuse to serve any type of eviction notice?	That is illegal and you should reach out for legal support.
